Unionism Restored in CRIN: Suspension lifted

Following the restoration of peace in the Institute since the assumption of office by Dr. (Mrs) F. A. Okelana and the return of normalcy, the Ag. Executive Director has deemed it fit to lift the suspension placed on union activities in the Institute since 2013 due to purported claim of obstruction of peace when the three in-house unions were demanding for justice and fair-play. The then Governing Board and Prof. M. O. Akoroda-led management team was aware that the protest against his mal-administration in 2013 was just a foretaste of what was to come as the staff embarked on mother of all protests in 2015 again (without the unions in place).

By 7:00am on Monday 2nd November, 2015, the Management and her security agents met the Institute gate locked and staff gathered demanding for the removal of Prof. Akoroda and dissolution of his management team.

The staff were guarding the gate both day and night preventing him or his agents from coming near the Institute thus paralysing activities for about several weeks until 22nd December 2015 when Mr President yielded to their demand and asked the erstwhile ED to proceed on indefinite leave for the Institute to function well again.

The Ag. ED, when ordering the lifting of the suspension, opined that existence of unions in an organisation is a positive thing as such would constantly put management on her toes, help in preventing avoidable mistakes and as well avail the system access to beneficial information in good time. Though, while she said all the in-house unions are now free to operate based on the



normalcy in the Institute through a circular dated February 1,2016, she however advised the unions to adhere to labour laws and all rules extant guiding the operational activities of unions as well as embrace dialogue.

Amid a woeful performance and tyrannical rule that has seen Prof. Akoroda replaced by Dr. (Mrs) Okelana, the researchers' output has also suffered, with scientists unable

The Ag. ED observed that the scientists were not overseeing activities in their respective areas of jurisdiction during the era of Prof. Akoroda that was ordered to proceed on indefinite Besides, the Ag. ED said that casual staff would be engaged to leave as everywhere was filthy and reports were not submitted and when done they are not of the desired qualities. Staff morale would definitely be at lower ebbs as they must have suffered individually and as a family too. The Ag. ED said efforts are in top gear to see that the 91 disengaged staff are re-engaged casual workers brought in as a payback to the community that accommodates the Institute as well as promotion of all legitimate and qualified staff.

Techno-serve organization's visit to CRIN

They were received by a team of CRIN scientists which includes Dr (Mrs) F.A. Okelana, Ag. Executive Director (ED), Dr. O. Olubamiwa, Dr O.O. Oduwole, Dr. A.R. Adedeji, Mr A.A. Oloyede, , Mr. B.O. Obatolu, Mr. A.H. Otuonye, Mr. M.A. Daniel Mr. A.E. Agbongiarhuoyi, Dr. A.V. Oyedokun, and Mr O.O. Adenuga.

The purpose of the visit was to know how CRIN is adopting Climate Smart Agriculture (CSA) in terms of resilience strategies to deal with the realities of climate change in relation to cocoa. The visitor is interested in the development of project proposal on climate smart Agriculture in the cocoa sub sector.

The Ag. ED intimated the visitor about some collaborative projects from some organizations with CRIN: They include Institute of Tropical Agriculture (IITA), IDH-Sustainable The working areas include; Trade Initiative, World Cocoa Foundation (WCF) and International Cocoa Organization (ICCO). Simon informed the gathering that CSA project could get funding from World Development (DFID) and International Fund for Agricultural Development (IFAD).

Nigeria's Cocoa Policies and International Development for SUSTAINABLE PRODUCTION

The meeting was attended by Mr. Friedel Hutz-Adams from SUDWIND (A Research Institute in Germany), Mrs Mope Fabunmi from Farmers Development Union (FADU), While CRIN team were made of; Dr. A. R. Adedeji, Mrs Yahaya, A. T., Mr. Oluyole, K. A., Mrs Lawal, J. O., Mr. Oloyede A. A., Mr. Shittu, T. R. and Mr. Taiwo Olayinka. Dr. Olubamiwa represented the Ag. Executive Director.

The aim of the International collaboration is to have a bilateral agreement to research into sustainability of cocoa among the eight leading cocoa producing countries of the world. However, three programs were highlighted to examine the sustainability of cocoa in the world;

- 1. Workshop in Ghana
- Working level conference in Cote d'Ivoire 2.
- 3. Collating of results and areas of needs for International support from the Government of Germany

- 1. Examine the different policies local, state, federal, etc., on training, research and marketing of cocoa in Nigeria
- 2. Pricing structure of cocoa
- 3. Price fluctuation
- 4. Cocoa value chain structure in Nigeria

Bank, Department for International It was agreed that at the end of the exercise, there will be improvement in cocoa production in Nigeria. The next meeting was scheduled as a workshop sometime in March 2016 in Ghana.

Pesticide residue assessment and safety standards of cocoa beans in Nigeria.

In view of the action of European Union (EU) to reduce levels of pesticide residue and safety of food products, the need arose to:

- carry out baseline studies on use, rate, timing and methods of pesticides application among farmers and warehouse agents,
- 2. assess pesticide residue limits vis-à-vis EU standard in ready-for-export cocoa beans in Nigeria and
- assess heavy metal (lead and cadmium) contents vis-àvis EU standards in ready-for-export cocoa beans in Nigeria.

On the whole, 12 local governments from 4 states in south-west (Ekiti, Ogun, Ondo and Osun States) were visited and 720 farmers were interviewed.

The information provided on the analyses of the cocoa beans (especially, if the limit are above standards) will help us design framework for training and sensitizing farmers on sustainable strategies for responsible pesticide application.

The training will eventually assist in re-orientating the farmers and boost the quality of cocoa produced in Nigeria, improve cocoa farmer livelihood and boost foreign exchange earnings.

Compliance – CRIN and Treasury Single Account by Ag. Head Account & Finance Mr. Onigbinde, O. O.

The Treasury Single Account (TSA) of the Federal Government is a policy of the Federal Government in trying to view all Federal Government funds at a glance.

Before the advent of TSA the Federal Government fund could not be tracked down easily and this was affecting the monetary policy and the cash in circulation.

Cocoa Research Institute of Nigeria, prior to TSA, had over 20 different accounts both at the headquarters and the six substations and as at December 2015 all the fund balance had been transferred to the TSA at Central Bank of Nigeria (CBN).

Presently four (4) different accounts had been opened for the Institute on TSA at CBN but the Institute is yet to access the accounts in terms of drawing and this is having adverse effect on the different projects being implemented by the Institute.

Determination of production potentials of coffee in Osun State

Coffee is one of the highly traded crop in the world market and globally the second consumed liquid after water. CRIN on the 29th Feb., and 1st March 2016 commenced a sensitization program among farmers in Osun State, to promote and encourage farmers to go back to production. The programme took place at Ijebu-Jesa town hall and FEG Agro Farms along Ijeda Road, Ijebu-Jesa. All Participants also visited some farms to know the status of coffee farming in the State.

Forty-two farmers were in attendance, drawn from groups such as; Cocoa Association of Nigeria (CAN), Sustainable Farmers Association (SUFA), Isoya Farmers Association, All Farmers Association (ALFAN) and Representatives from both Ministry of Agriculture and Osun State Agricultural Development. The Participants were made to understand the potentials in coffee production. Jointly, the farmers promised in different farm sizes, to cultivate 352ha as soon as this year's rain is established.
